- Pay-At-The-Door Option: **\$45** at the door. Registration will be between 5:45-6:10 p.m. prior to the interviews beginning. Entry forms must be printed and completed prior to registering at the door. There will not be any extra forms provided. *Participation t-shirts will be limited for those picking this option. First come, First serve.*

- Interview and Opening Number outfit to be the same
 - *Please wear interview appropriate dress attire- dress for interview!*
- Evening Gown

Stage will have a simple elegant look to it (white, black, silver, splash of color)

RULES & REGULATIONS:

1. This pageant is open to all residents of Kentucky.
2. Contestant must have reached her 13th birthday by/on October 31, 2018 and cannot have reached her 16th birthday by/on October 31, 2018.
3. Contestant must be female, single, never married or have never had any children.
4. Previous year winner must sit out for one year only.
5. The winner will represent the Boyle County Fair at the Miss Teen Kentucky County Fair Pageant in Louisville in October 2018.
 - a. In the event that the winner is unable to attend the state pageant, she must let her director know **at least three weeks in advance** to allow time for the next available runner-up to register. If the winner does not notify the director in the aforementioned time, she will be obligated to forfeit her crown & sash to the next available runner-up, as well as to refund all expenses the Boyle County Fair has provided. Exceptions will be considered for emergencies (death in the family, illness, etc.) and proof of emergency may be needed.

- b. Winner may also be expected to participate in local events/parades throughout the year. Parents and contestants will be notified in a reasonable amount of time prior to the event with any information.
 - b.i. Please keep the first weekend of December 2018 free for possible participation in the local Christmas parade. Director will provide parents with more information closer to event time.
6. Contestants will compete in interview, opening number, and evening gown. Interview attire will also be worn for opening number. Individual two minute interviews will take place with the judges prior to the pageant beginning. Contestants will introduce themselves during the opening number.
7. **IMPORTANT***: winner MUST find pageant director immediately after the pageant to discuss the state pageant paperwork. *This paperwork MUST be completed and sent in to state within TWO weeks of the Miss Teen Boyle County Fair pageant.*
8. Awesome prize package to be awarded to the Miss Teen BCF winner including: cash, crown, sash, trophy, and lodging provided for the Miss Teen state pageant in Louisville. Awards will also be given out to 2nd place, 3rd place, and Miss Congeniality... as well as an interview award, opening number award, and an evening gown award.
9. There will be a dressing area available. Please bring a mirror for personal use.
10. Decisions of the judges are FINAL. No scoresheets will be handed out.
11. Parents, please be advised that there is a \$12 admission fee into the fairgrounds.
